ABOUT THIS ISSUE:

We are once again looking for an Editor of the newsletter due to resignation of the current Editor. Minutes of the ExComm Meeting - September 7, 2003

The ExComm met at the home of **Clara Woodall-Moran** on September 7, 2003. Call to Order at four PM.

Members present: **Clara Woodall-Moran, Rita Johnson-Aronna, Helen Lee Moore, Sam Kirschten, and Joe Smith.**

Welcome guests: **Pat Aronna, and Dan Morgan,** Editor of Owl-award winner *The Scam*.

Minutes for August 3, 2003: changed MENSA to SCAM, remainder as printed. [Recording Secretary now recognizes we are SCAM, and changes prior references MENSA to SCAM *nunc pro tunc*] Move **Helen Lee**, second **Joe**, vote unanimous to approve as changed.

Correspondence: none.

Reports: Editor: The Editor of *The SCAM* needs an original copy of the software to produce *The SCAM*. The ExComm will not purchase software. If a gift or loan is not made we have a crisis.

Circulation: Unpaid subscribers having been notified, their subscriptions have been stopped.

Mediator: the ExComm is this group's Ombudsman - no activity.

Scholarship: **Rita** has selected the winner from 10 applications. **Helen Lee** will procure the scholarship check and **Clara** created the certificate. Presentation will be at the next S.N.O.R.T. September 27. **Rita** is working on funding future scholarships; **you** can help.
