**F**ellow SCAM Members, if you are like me, and sometimes just skim through the newsletter, then jump to the last paragraph to get to the main message of this article. Otherwise read on.

We have reached a point in the preparations for our Regional Gathering (RG), coming up in October, where we must determine if our available resources and committee staffing are adequate to put on an event that meets the level of excellence that has been the trademark of all of SCAM's previous RG's.

In order to plan, prepare and run an RG that is up to our standards (and our guest's), our experience shows that we need a quantity of 16 individuals, specifically committed to an assigned task at least three months prior to that event.

Some of these assignments require activity prior to the event (planning, scheduling, supply pickup...etc.) and others require attendance at the event and readiness to work.

Some examples of these assignments are:

- Chairperson
- Assistant Chairperson
- Hotel Liaison
- Goody Bag Coordinator
- Publicity Coordinator
- Registrar
- Registration, Sign-in Table (quantity 2 each Friday Night, Saturday Morning)
- Games Coordinator
- Scholarship Fundraising
- Hospitality Supervisor
- Hospitality Assistant (we need 6 person/days of help here – 2 people a day for 3 days – all day and late Friday and Saturday)
- Programs Coordinator
- Costume Pageant Coordinator
- Treasurer
- “Go-Fer”, Runner, Standby Helper on all three days of the event (we need 6 person/days of help here – 2 people a day for 3 days – all day and late Friday and Saturday))

As can be seen by the list above, the amount of work and the level of commitment to present a successful RG are quite daunting when looked at from the perspective that currently we have only 7 firm commitments from members. This will only continue to get worse for us as we move forward. We are very distressed at this prospect, both for the financial loss for the non-refundable deposit with the hotel, and for the overall disappointment of those who were looking forward to the RG, but we cannot afford to find ourselves in a situation where we would have to compromise SCAM's long running standard and reputation of putting on one of the finest RG's in the entire country. We are requiring attendance at the meeting, because we need to be sure of the level of commitment of our volunteers and figure a couple hours of your time will suffice in showing us that you are ready to join us in putting on an RG we can all be proud of. **A FELLOW  
MENSAN IN  
NEED**

**T**his installment is a departure from my usual political commentary. It is not “writer’s block”, nor is it because there is nothing in the political arena to write about. Be assured neither is the case. As vitally important as I believe politics to be, especially in a Presidential election such as this one, there are those rare occasions when something comes to light that is far more important than even politics. I believe this to be one of those occasions. Please read on.

The topic this month concerns a fellow Mensan. Shortly after last month’s SCAM went to the printer’s, I learned from a fellow editor the horrifying experience this individual is coping with. At this point, let me introduce you to Dr. Robert Strippy, a retired history professor. Bob, 70 and in poor health, is a long-time member of Thomas Jefferson Mensa, located in Virginia. Bob has been LocSec and was Editor of the *Sally Hemings Memorial Newsletter*. Bob is currently incarcerated in the Augusta County Jail awaiting the outcome of his case. This is how the case starts:

*“In August 2002, Bob was enjoying the sunset at one of the Blue Ridge Parkway overlooks when he was attacked by a younger man wielding a cudgel. While being beaten about the head and hands as he tried to start his vehicle and get away, he remembered that his friend, Erin, had left her (legal) handgun in a gun-box under the seat of the vehicle. He managed to get the gun out to scare the assailant away, but the man got even madder and more hysterical, threatened to kill Bob with the gun, and grabbed for it. When the attacker yanked on the gun, it went off, wounding him, and Bob was able to get away. Bob immediately reported all this to the authorities, and, the next morning, was seen by his doctor at UVa (University of Virginia Hospital) to document his injuries. (1)”*

The matter now gets worse:

*“Unfortunately, the authorities in Augusta County chose to believe the unsubstantiated story told by the attacker (a previously convicted felon), who maintained that Bob had shot him for refusing a sexual solicitation. Unable to afford a private attorney, Bob had to rely on the Public Defender’s office for representation when the trial was held this past August (a year later). At that trial, a number of things went against Bob...one of the most important of which was that the medical records that would validate Bob’s testimony were not subpoenaed in time to arrive for the trial, and the judge refused to grant a delay until they could arrive. As a result of these problems with his defense, a jury convicted Bob of “malicious wounding” and “felonious use of a gun during a felony (malicious wounding)” and recommended a ten year sentence (a virtual death-sentence for one in Bob’s poor physical health). (1)”*

Further complicating matters is Bob’s health, and how his condition is being handled while in custody:

*“That is certainly not good news for Bob, who in that 8 months had suffered 15 trips to the Emergency Room, and whose health has deteriorated markedly as a result of his incarceration in the Augusta County Jail. Also unfortunately, being transferred to a state facility while the appeal process is underway will probably cause him to die even sooner.*

*He was transferred without any indication of even having any medical history much less any records of his actual condition. The Virginia Department of Corrections blindly maintains that they don't need anything other than what their own "professional" medical staff can discover about any inmate. So far, they have denied him several of the medications that he had been on previously, telling him that they were too expensive to provide. They won't even let him have his nitroglycerin spray for the severe angina he gets from the flight of stairs he must climb for every meal and every medical check. (2)"*

Although this only scratches the surface, I believe you get the picture. So, why am I writing about this? First, as you can see in Bob's case, Mensans are certainly not exempt from miscarriages of justice or from mistreatment in jail. One must wonder why the trial judge refused to wait for the medical evidence that was crucial to Bob's defense. One must also wonder why we still permit the kind of treatment Bob experiences at the hands of the Department of Corrections.

Secondly, members of Thomas Jefferson Mensa (TJM) are coming to Bob's aid. They believe in him. There is a defense fund for Bob's appeal. TJM members are appealing to us for any help we can give, whether it be contributions to the defense fund or simply writing Bob a letter to help him maintain his sanity. I can only hope Bob will live long enough to see his name cleared. Thirdly, although I do believe Bob is innocent of the criminal charges against him, this is NOT about his innocence or guilt. It is about a fair trial where both sides can present all the relevant evidence in the matter. It is also about fair and humane treatment of prisoners, especially those who are elderly and seriously ill.

While I support the effort to help Bob Strippy, I cannot, on behalf of The SCAM or Mensa, solicit any aid; I am personally appealing to you, and encourage you to consider the issue. I can only ask that you let your conscience be your guide.

## ***The Alchemist:***

### ***LOW EXPENSE RATIOS***

One of the big advertising kicks today from mutual funds is to tell how low their expense ratio is and that you will make a great deal more money if you buy and hold with them. Partly true, but that is not the whole story.

What is the expense ratio? It is all their overhead including but not limited to all the managers and other employees salaries, rent, computers, utilities, travel (the fund manager says he has to visit a company in Florida in the winter to see how it is doing), advisory services, telephone, etc., etc, etc. Oops, and don't forget the manager's bonus whether he makes money for you or not. If the fund has one billion (yes, that's a B) that means they can spend \$10,000,000 on expenses and no one will complain because it is a tiny 1%.

At some point expenses just about stop going up as you don't need very many more people to manage the paper work for a billion than you do for 250 million. The fund manager's duties remain the same just the size of the orders he places changes. Actually as a fund grows in size its expenses should automatically come down as a percent of assets, but you will find that is not the case for many funds. They keep sticking it to their investors who don't have any idea how egregious this is.

The larger the fund family the lower should be their expenses per fund as they can outsource from the fund to a central billing and customer service desk. Vanguard Funds has more than 100 individual funds in its family and they brag on how low is their expense ratio. It should be as they have more than Billion spread out over those funds. They keep their expenses low and at only 1/2% they can charge about 360 million to offset their overhead.

Many funds run very high expenses. This is especially true for new and smaller funds, but as they take in more money they can spread their expenses and lower their ratios. One of the recent criticisms of funds is they have been making extra charges labeled 12B-1 that are supposed to be expressly for promotion to bring in new customers. Unfortunately, some (not all) of the fund managers have been pocketing this. If this does bring in new money then the expense ratio should fall and again in many cases it has not.

Investors expect fund managers to be honest. When large sums of money are at stake it seems to bring out the worst. That real nice fund manager turns into a hungry wolf and the investor becomes one of the 3 little pigs that did not escape.

**ANTOINE'S**

To many people New Orleans is the best eating town in the U. S. That is a moot point, but the Crescent City is no doubt one of the best. Aside from the expected Cajun and Creole cuisine, there is a plethora of French restaurants and a smattering of restaurants that specialize in other cuisines. Two of the best French restaurants, Arnaud's and Antoine's, are particularly upscale, until recently requiring jackets for the men for the evening meal, an unusual requirement in a town that calls itself the Big Easy. About one year ago Arnaud's decided to rescind the jacket and tie requirement for men. So goes elegance in the U. S.

Antoine's is especially interesting. It claims to be the oldest restaurant in New Orleans having been founded over 160 years ago in 1840 by Antoine Alciatore. His descendants, the fifth generation, still own and run the restaurant.

As with several other old restaurants, such as the Columbia in Ybor City, the restaurant began with one dining room and expanded over the years by adding room after room as necessitated by the restaurant's popularity. Today there are 15 dining rooms, the smallest accepting only two and the largest with a capacity of 300. Many of the rooms of various sizes are suitable for private parties and conventions.

The main dining room, named the "Original", is the one that you enter from the street. It is a square room with a high ceiling. It has about 20 tables covered with white table cloths. The cloth napkins are also plain white. The room is plain, but not stark. The walls are generally undecorated except for a group of family portraits over the counter. It has a feeling of old-fashioned restrained elegance befitting the era of the restaurant's founding.

The walls of some of the other rooms are covered with mementos, such as photographs of famous people who dined in the restaurant. I spotted a picture of Franklin D. Roosevelt. Another room has framed menus from the earliest times to the present. Still another has a *melange* of souvenirs. A waiter pointed out the beret that Groucho Marx wore on a European tour.

The waiters in the main dining room, I counted 16, which makes a ratio of about one waiter for two tables, a high ratio that was reflected in the high-quality but not over-bearing service. Also most of the waiters were middle-aged men indicating that they were professionals who had probably been with the restaurant for many years.

There is a vast wine cellar that can be observed through a glass panel. Outside of the wine cellar is a collection of hundreds of bottles of liquors and brandies on display, some of which appear to be ancient.

Eating in Antoine's is not inexpensive, certainly not by Brevard County standards. The menu is an impressive affair of eight pages. One page is devoted to appetizers with things like four ways of preparing oysters, two forms of snails, five preparations of shrimp, and three crawfish items.

Rita and I started our meal with American caviar. It was served in

the traditional style with toast points, chopped onion, and chopped hard-boiled egg (see my article of January 1996, "Caviar" for my opinion of serving chicken eggs with fish eggs). This was my first acquaintance with American caviar. The eggs were tiny and black, much smaller than the Beluga, Ossetra, and Sevruga from the Caspian Sea. However, the flavor was excellent. This caviar came from California. With sturgeon a world-wide fish found in most of the great rivers, and caviar being such an expensive delicacy, it is surprising that more caviar is not produced outside of the Caspian sea. For a detailed discussion of the history of caviar including American caviar I recommend Inga Saffron's book *Caviar*.

We followed this with Vichyssoise, the cold potato soup. This too was excellent, although the accompanying bread, served hot, although very good, was a bit too dense and the crust not as crisp as I have had in France or even in the Columbia restaurant.

There were pages of fish, eggs, entrees, sauces, vegetables, salads, cheeses, desserts, and coffees.

For the main course, Rita had lobster Thermidor, lobster meat in a cheese sauce. I had *riz de veau* (sweetbreads). They were offered *a la financiere* (in a sherry wine sauce), but I had mine prepared by frying them in butter along with sliced mushrooms. Sweetbreads have a delicate flavor so it is best not to put a heavy sauce over them. A half a lemon was supplied with the sweetbreads which was just enough of a seasoning for them. The sweetbreads were somewhat dry, but still very flavorful.

For dessert Rita had flan, caramel custard, and I had chocolate mousse. Here the mousse was flavored with rum, a happy combination.

We finished the meal with New Orleans coffee (with chicory).

**L**ast month I wrote about the sins of omission perpetrated daily by the Left and their sycophants of the so-called mainstream media. This month I will again touch on that practice as well as how it leads to sins of commission. Without doubt, the most publicized news item of the past 6 weeks has been the "tortures" of the Abu Ghraib prisoner abuse. To the Left, literally ANYTHING that can be done to lessen President Bush's re-election is considered front-page major news and is treated with the same hoopla that the invention of a water-burning automobile engine would be. We have been seeing the abuse photos and heard the Dan Rathers of the media reporting on the humiliating mistreatment of the Iraqi terrorist prisoners by American MPs. No one has been shot, had body parts detached, or been otherwise physically harmed, although I did see one report that one prisoner had been bitten by a K-9. Strangely, though, I did not hear any demands from the Left for the removal of all military women from the Iraqi forces.

Something for the indignant left to consider: the "abuse" and "humiliation" that these terrorists have undergone is little different than that of a fraternity hazing. And the reported physical abuses sound strangely like the psychological treatment our military personnel have undergone to prepare them in case of capture during war. And for good reason – they are proven methods for obtaining information

to see Abu Ghraib, the same media spent all of two days on the brutal beheading of Nick Berg. It was front page for one day. Why the difference in treatment? Nick Berg got little coverage, and no video was shown of the act. As Sen. Zell Miller of Georgia asked, "Why is it that there's more indignation over a photo of a prisoner with underwear on his head than over the video of a young American with no head at all?"

There is only one reason: because Berg's murder only proves that we really ARE at war with terrorists, and that doesn't do anything to damage President Bush. That is also the same reason the media is adamant about not showing the collapse of the Twin Towers anymore, and were among the loudest critics of the President's use of a 2-second shot in a campaign ad.

And the same idiots crying "torture" and "abuse" at the Administration and the military have actively suppressed the truth of real torture under Saddam. A video of scenes more suitable for Dante's *Inferno* or a Hollywood slasher film was brought to the attention of the Media by the news director of Al Hurra, a satellite channel reaching 22 Arab countries. Mouafac Harb told the Post that he obtained the new torture video on Monday, May 17 and deemed the images both authentic and newsworthy.

The Washington Post admitted on May 21 that it was in possession of some of the gruesome torture images - but did not publish them in a report on the video buried on Page A21. Instead, Post editors decided to front-page stale images of Abu Ghraib abuse.

"The [Hussein torture] video reached news outlets," the paper explained, "as senior spokesmen for the Bush administration began to express frustration that the treatment of Iraqi prisoners by U.S. troops had overshadowed well-documented human rights horrors of the Hussein era."

In the video (not yet broadcast by any U.S. media outlet), Hussein torture victims are shown being flogged and having fingers chopped off. One detainee is filmed as he is thrown from a roof, another is beheaded by a sword-wielding member of Saddam's elite Fedayeen unit.

According to the Post, the video of the beheading shows a man placing the severed head on the victim's prone body. Another scene shows a man's tongue being cut out.

Yet more gruesome images from the media-suppressed video include scenes of Kurdish detainees being castrated and babies being gassed to death.

Speaking of being gassed – did you note the strong coverage by the media of the terrorists' attempt to use a shell containing one gallon of Sarin against our troops in Iraq? No? Well, that's understandable. The unclassified October 2002 *National Intelligence Estimate* stated that Iraq "has begun renewed production of ... sarin" and other chemical weapons, and estimated that Saddam Hussein had between **100 and 500 metric tons** of chemi-

cal agents. Oh, just for your consideration: one tanker truck of the size you see every day delivering gasoline can contain between 8,000 and 10,000 gallons. Which equals about **40 tons**. If it carried Sarin that would be enough to kill about a half a BILLION people. Now try to find just one container that size buried in an area the size of California. So the discovery and attempted use of enough chemical agent to kill 60 THOUSAND people doesn't merit much attention. It's not really a lot of a weapon of mass destruction. The "abuse" of the people trying to use that shell is far more newsworthy... at least in the minds of the media.

Now, ask yourself this question: Where is there any equivalence between photographing a naked male prisoner with panties on his head, and actually flogging, dismembering, and beheading him?

Also ask yourself why the media so adamantly refuse to show any footage of the fall of the World Trade Center, of the Americans jumping to their deaths rather than burning. Why no repetitive reviews of the video of the gloating bin Ladin and the celebrating Arabs after the towers fell?

If the Media were consistent, there could be only one answer: they do not want to remind America that we are at war. They do not want America united against a common foe. And they most definitely do not want America united under the leadership of George W. Bush. So they do their best to broadcast to America, and the rest of the world, every single thing they can come up with to downplay the successes for Bush and the War in Iraq, and to divide the support for both at home and abroad. And by so doing, they knowingly accept their sin of commission: they give comfort to the enemy and encourage them to continue to attack our troops, our allies, and our interests. Because the terrorists know that, no matter what they do, if the results hurt the image and re-election chances of President Bush, they will get more play time with the media than the capture of Saddam, or the attacks of 9/11, or the discovery of weapons of mass destruction ever did, or ever will.

The author's conservative friends tend to extol the virtues of the private sector and “market forces” as solutions for the economic problems that confront our society. To which this author responds...with a hearty “Amen!” After all, in a democratic-capitalistic system, it is the innovator developing new products and services who makes the greatest contribution to increased employment opportunities, and to building the wealth of the community. Indeed, the innovator should be constrained only by his or her own conscience, and by the laws that are established by the people's representatives for the public interest.

Unfortunately, in economic policy, as in so many other areas, the modern conservative movement fails to match words with deeds.

Let's take the curious case of Creekstone Farms Premium Beef LLC. As the name suggests, Creekstone Farms is a small beef producing and processing company that specializes in premium products both for the domestic market and abroad, especially Japan, where American beef is highly valued. They operate a packing plant in Arkansas City, Kansas, that directly employs approximately 800 people. It should be noted that due to other plant closings in the vicinity, Arkansas City is located in a depressed area, and the positive economic impact of a viable employer resonates throughout the community.

Unfortunately, after an incident of bovine spongiform encephalopathy (BSE, or “mad cow disease”) occurred in the United States in late 2003, the Japanese government prohibited the importation of American beef. In Japan, 100% of domestically-produced beef is tested for BSE, and the Japanese government now insists that 100% of imported beef must likewise be tested.

Creekstone Farms took a novel approach to this threat to their business. *At its own expense*, Creekstone has established a laboratory at its Arkansas City facility, hired specialists, trained its workers, and procured the test equipment in order to conduct 100% testing for BSE. (Interestingly enough, the test materials are manufactured in the USA, but are used in Japan and France.)

Additionally, Creekstone is interested in marketing BSE-tested beef in the United States.

The next chapter in this story should be whether Creekstone's \$500,000 gamble pays off, and they are able to reenter a key market for an American industry. Wrong! The Bush Administration's Department of Agriculture has actually prohibited Creekstone from conducting testing above the minimum requirements. The rationale was a phrase we hear often when conservatives need an excuse to do nothing about a problem,

as in this case, when the Department of Agriculture claimed the added testing “is not scientifically justified.”

Even though no tax money is being spent, and Creekstone Farms has actually incurred substantial business risk, the Bush Administration is preventing an American company from marketing its products.

So far, Creekstone Farms has had to lay off about 50 workers, and is losing approximately \$100,000 per week.

It is important to note here that no one involved is pushing for 100% testing of domestic beef for BSE. Also, this story does not address the broader issue that the current system of random poke-scratch-and-sniff inspections may not be the best our government can do in protecting the food supply in the 21<sup>st</sup> century.

What is at stake here is that an American company is willing to accept the expense of a half million dollars going above and beyond the minimum government requirements in order to gain a competitive advantage, and is being prohibited from doing so by an agency of the government. This appears to be a typical “craziness-inside-Washington” story that conservatives are so fond of relating to advance their philosophy of laissez faire government. The truth is that it is a conservative regime responsible here, and the story actually has logic, albeit twisted logic.

Instead of protecting us, the Department of Agriculture under Bush seems to be primarily concerned with protecting big agriculture from any pressure to upgrade its standards of inspection, either from competition by other producers who go beyond the minimum requirements, or from the threat of more stringent regulations in the future should scientific knowledge ever justify such measures. We have a case of a small company attempting to profit by investing in process improvements and delivering a superior product. In contrast, a cartel of big corporations is pursuing a short-sighted strategy of minimizing all costs and refusing to invest in improvements. The big corporations, who never miss an opportunity to complain about the government, are manipulating that same government to crush their competition.

***Which business model represents the American way?***

The attitude exhibited by the Bush Administration also serves to stifle any scientific inquiry into the adequacy of existing safety measures or potential improvements in inspection, so that there will always be a “need for more information.”

Our President, who “trusts the people, not government,” apparently doesn’t trust the people to make an informed choice about the food they consume. Our President, who blames “the bureaucracy” at every opportunity, is quite willing to turn employees of the Executive Branch into the handmaidens of big corporations (who make big campaign contribu-

tions, and tend to open a revolving door to out-of-work politicians).

One wonders if the cows are really the ones we should be watching for crazy behavior.
