

Part 2: Urinals

Men's urinals come in several basic types. The trough type has two subcategories, wall mounted and floor. The trough type provides no privacy, is simple of construction and is easy to clean, that is, if it ever does get cleaned. There is the story about a bar in the wilds of Alaska, apocryphal no doubt, where in the winter it was too cold for the patrons, all men of course, to go outside to the unheated outhouse after drinking their beers. The owner of the bar solved the problem by installing a trough urinal on the face of the bar and piping it to the outside so the men could drink and urinate at the same time without leaving their stools. I searched Alaska but I couldn't find that bar.



Trough urinals are still found occasionally. One pictured is from England. An example of a floor type trough urinal is found in the Barbican Arts Centre in London. Another rarely found type of urinal is the full length or floor model, although this type was once the very common. The full-length model has several advantages. With such a large target area it is difficult for the patron to miss the mark. Also, if mounted flush with the floor, cleaning the toilet room is simplified. No floor drain is required; the floor is washed down and swept into the urinal.

A full-length urinal can be found in the men's room at Erna Nixon Park in Melbourne. This one is not mounted flush with



the floor. Another full-length urinal pictured is in the men's room of the Waldorf Hotel in London, a very posh establishment. Note the screen to prevent splashing one's self. These screens are very rarely seen on floor urinals. The old pissoires of Paris were in essence a large circular floor trough urinal. The original Crapper urinal shown is not in use. It stands on display outside the modern Crapper factory in Avon.



Floor urinals for the most part have been replaced in contemporary construction by wall mounted urinals. Wall mounted urinals are preferred by most building owners because, like wall mounted toilets, they leave the floor unobstructed and therefore easier to clean. Whether they

are

less expensive to install is a question to be analyzed. If the wall-mounted urinal is plain, the fixture itself may cost significantly less than the full-length urinal, but if it is fancy, the fixture may cost more, many times more. But the wall-mounted urinal needs a strong support built into the wall, just as a wall mounted toilet does, to support the full weight of a man. In order to accommodate the various heights of the men and boys using them, banks of wall-mounted urinals are often mounted at various heights, something not required of floor-mounted urinals.



However, some wall mounted urinals have such a small target area that a particularly short or tall man would find them difficult to use. The ones shown are in museums in Vienna and Paris. Similar urinals are found in other museums around the world. Is there something about male museum patrons that I don't know?

Some of the more unusual urinals that I have seen have been of the wall-mounted variety. Virgin Atlantic wanted to install a urinal called "Kisses" in its private lounge in Kennedy Airport in New York. That urinal is found in several places around the world. Within a week of the announcement, the outcry from feminists was so great that Virgin Atlantic dropped the idea. NOW even has a web site through which you can send your objections to Virgin.



Wall mounted urinals in past years were simply mounted on the walls. In recent years privacy barriers between the urinals have become the vogue. Building codes are now being rewritten to require such barriers. It seems that men are becoming more shy or sensitive about urinating in view of other men. The medical condition is called paruresis or shy-bladder syndrome. Some men find it difficult, if not impossible, to urinate

if someone else is close enough to see or hear. Mental health experts say this phobia troubles an estimated seventeen million Americans to some extent, but few will talk about it. But the modern version of the open-air public urinal provides less privacy than the now defunct pissoires of Paris. For all the interest in increasing privacy for men urinating, many American movies and TV shows have an obligatory scene in a public toilet with men urinating on screen.

I have not had much time for prowling bookstore so I missed a “cozy” from one of my favorite authors. Diane Mott Davidson has as her main character, a woman whose job is catering and often finds herself embroiled in mysteries and mayhem.

Even motivations and resources are not set in stone. Some are driven by a need to acquire money. Same money, same person, at the end of the week, they are suddenly driven by the urge to spend that money! Go figure.

President Bush strongly advocates “common-sense medical liability reform” to prevent “frivolous lawsuits.” Not surprisingly, these “reforms” primarily restrict the size of jury awards, and impede the ability of consumers to seek relief in the court system. Seems like the President had all the information he needed to make that call.

SOMEONE WHO DIDN'T GET THE WORD

If there is anyone who has not yet learned that all critics of the Bush Administration’s policies will be silenced, we now have the case of Ms. Bunnatine Greenhouse to consider.

Until a few weeks ago, Ms. Greenhouse was the senior civilian procurement official for the U.S. Army Corps of Engineers. Ms. Greenhouse has been outspoken in protesting irregularities in the Corps of Engineers’ award of a no-bid contract to the Halliburton Corporation to restore oil fields in Iraq. Not only was Halliburton pre-selected as the only supplier, they previously had the opportunity to write the cost estimates and the plan for how the contract would be executed. Ms. Greenhouse has testified before Congress regarding this and other aberrations in the supposedly competitive process by which the Corps of Engineers assures best value to the taxpayers when awarding contracts.

Why should a civil servant get in the way of Halliburton’s opportunity to realize another major profit stream from the current war in Iraq? Why should anyone question how this administration spends the taxpayer’s money, when this administration has given so much money back to the taxpayers (well, at least given it back to the taxpayers in the higher income brackets)?

Any loyal, red-blooded American knows that what is good for the Halliburton Corporation is good for our country, and vice versa. Obvi-

AN UPDATE

In a decision handed down by a three-star General in her chain-of-command, Major Kaus' dismissal from the Army has been overturned (although her sentence has already been completed). She will be able to retire with her full rank and benefits.

Additionally, outstanding punishments to Major Kaus' former subordinates have also been commuted.

Although the offices of Senator Nelson, Senator Martinez, and Congressman (for life) Weldon each responded, the author never received so much as an acknowledgement of his letter from the office of the President. This is presumably the same President who likes to talk about how he cares so very, very deeply for America's men and women serving in uniform.

Hickory Avenue in Jefferson (Parish) and historic district development in Westwego.

So, what is it? Is "W" truly this almighty, omnipotent being who can cause disasters of biblical proportions through either action or inaction, or is he simply a man being used by liberals as a scapegoat for their own blatant incompetence and inadequacies?

I tend to lean toward the latter. For one, I am a logical individual who doesn't believe in the divinity of the President. Two, I believe that, were he truly divine, he would have already smitten his blasphemers.

Except, of course, for his divine mercy and compassion.

One hardly can talk about politics anymore, it seems, without getting into a fruitless debate about whether or not the Ten Commandments can be displayed on public property (in this context, courthouses, capital buildings, city halls., etc.), where it can be displayed and under what circumstances. One position, articulated by the ACLU (known by some as the Anti-Christian Litigation Union), is that the Establishment Clause of the First Amendment does not allow such a display, since it endorses Christianity as the United States's official religion. Others contend the Ten Commandments reflect our "Judeo-Christian" ethic. Despite the debate, the Ten Commandments displays do enjoy considerable popular support.

Do we, then, allow for such religious displays on public property? Since "we, the people" do not seem to believe what we read in our Constitution, we will set that question aside and instead ask, "Do the Ten Commandments accurately reflect official American policy?" What about our Judeo-Christian ethic? According to the Christian Coalition, founded in 1989 by televangelist Pat Robertson: "...we (the Christian Coalition) continuously work to identify, educate and mobilize Christians for effective political action! Such action will preserve, protect and defend the Judeo-Christian values that made this the greatest country in history."(1).

In case anyone missed it, on August 22, 2005, history was made. On that day, Mr. Robertson (yes, the same one) stated on his television show, The 700 Club, that the United States should kill Venezuela's president Hugo Chávez. In his words: "*If he (Chávez) thinks we're trying to assassinate him, I think that we really ought to go ahead and do it. It's a whole lot cheaper than starting a war. And I don't think any oil shipments will stop.*"(2) It is interesting to note that Venezuela has the largest oil reserve outside the Middle East. Apparently, Chávez's opposition to President Bush and globalization's effects on his citizens prompted Mr. Robertson's suggestion. Why, to date, has no one from the current Administration officially repudiated Mr. Robertson's statement? Read on, the answer will be readily apparent.

Of course, the idea of assassinating foreign leaders for "American interests" is not a new concept, nor did it originate with our current Administration. Back in October 1970, the CIA plotted to assassinate Chilean President-elect Salvador Allende: "*It is the firm and continuing policy that Allende be overthrown by a coup...*' 'eyes-only, restricted handling, secret' message. To US station

chief, Santiago. From CIA headquarters. 16 October 1970. '... You would be wrong to assume this plan for mayhem was another manifestation of the Cold War between the 'Free World' and communism. Much more was at stake: Pepsi-Cola's market share and other matters closer to the heart of corporate America.'"(3) It seems Allende, a Marxist, had been planning to nationalize Pepsi's Chile bottling plant.

As evidenced by the now-infamous War on Iraq, it no longer takes an act or threat of aggression for the leaders of the United States to wage war on another country. Since the War on Iraq is apparently an integral part of the current Administration's "War on Terror", it is only fitting that we briefly examine that issue. According to the Project for a New American Century, of which signatories include Vice-Pres. Dick Cheney and Secretary of Defense Donald Rumsfeld, explaining the need to take over Iraq: "...the need for a substantial American force presence in the Gulf transcends the issue of the regime of Saddam Hussein." (4) Yet, the policy was so radical that even its authors realized "... it would be impossible to implement 'absent some catastrophic and catalyzing event—like a new Pearl Harbor.'" (4) Or, in this case, the 9/11 attacks (that did not even involve Iraq)? How many innocent people – both American and Iraqi – were forced to pay for this policy with their lives? I do not have the current figures, but they number into the tens of thousands.

By this time, it should be evident to all that Pat Robertson, with his "off the wall" comment, simply let the cat out of the bag – all he did was articulate our "Judeo-Christian" leadership's unspoken policy. At this point, you may be asking, "What does this have to do with the Ten Commandments?" For all the hullabaloo about the Ten Commandments reflecting our national policies, one minor issue seems to have been missed. One of the Ten Commandments states unequivocally: "Thou shalt not kill." How does this square with our national policy of killing people when it is convenient for the powers that be to do so? Well, it seems the cat truly is out of the bag: *On that fateful August day, Christian Coalition Founder Pat Robertson repealed the Sixth Commandment!* Anyone game for a Nine Commandments monument?
