**In my first article** in this series, I mentioned that this ship had no urinals. That referred only to the public men's toilets, of which I visited all. In the public men's toilets there were only fully enclosed stalls, with the sides and the doors going only a few inches from the floor to only a few inches of the ceiling, making it virtually impossible to look into a stall even if lying on the floor. Inside each stall was a standard commode.

As for the crew areas, I did not penetrate that far, and I can vouch for only our cabin although I would not expect to find urinals in any of the cabins as they are not usually provided in other ship's cabins, hotel rooms, or homes. Urinals in public men's toilets were to be found on every ship on which I traveled, except this one. Why would this be so?

The *Poesia* was launched in 2008. Two other MSC Ships, the *Lirica* was launched in 2003 and the *Opera* in 2004. Each of these other ships had urinals in their public men's toilets.

I contacted MSC to query them about the lack of public urinals on the *Poesia*. They replied only that it was a different design. I could not get any further information from them.

I refer you to a chapter in my book *The Toilet Tractate*.

### CHAPTER 13. MUSLIMS

In the western world we assume that the normal position for a male urinating is upright, that is, standing. The majority of men in the western world do that. But in the Muslim world, which covers much of the Earth, that is not so. Islamic *sharee'ah* (The code of law based on the Koran. In many Muslim counties there is no distinction between religious and other matters, all is religious.) includes a number of rules and etiquettes to be followed when answering the call of nature. What follows is an explanation of some of the rules governing urinating from a Muslim source. The source also provides extensive explanations of the laws regarding defecation. Rather than paraphrase the religious rulings, I present them as written but I have edited them for simplicity and clarity, but retained the language as written.

Not to face the *Qiblah* (direction of prayer, i.e. the Kabala) when urinating. This is out of respect for the Qiblah and for the symbols and rituals of Allah.

He should not touch his penis with his right hand when urinating, be-

cause the Prophet said: "When any one of you urinates, he should not hold his penis in his right hand or clean it with his right hand."

The Sunnah is to answer the call of nature sitting, making oneself close to the ground, because this is more concealing, and makes it less likely that spray from one's urine will come back on one's body or clothes, making them dirty. If a person can be sure of avoiding this, then it is permissible to urinate standing up.

A person should be concealed from the sight of others when answering the call of nature. If a person is out in an open space and cannot find anything to conceal him when he needs to answer the call of nature, he should move far away from the other people around him.

A person should not uncover his 'awrah (private parts) until after he has squatted close to the ground, because this is more concealing. If a person is in a (modern) toilet, he should not lift his garment until he has closed the door and is out of sight of other people. With regard to this point and the one before, it is worth noting that the habit of many people in the West and elsewhere, of urinating in a standing position in front of other people in public toilets (using urinals) is something which goes against good manners, modesty and decency, and is repulsive to anyone who possesses sound common sense and wisdom. How can anybody uncover in front of other people the 'awrah (private parts) which Allah has placed between his legs to conceal it and commanded him to cover it? The idea that it should be covered is well established among all wise and decent people of all races. It is wrong in principle to build restrooms of this shameful type, where the users can see one another, thus making them worse than some kinds of animals whose habit is to conceal themselves from one another when urinating or defecating.

He should be careful to remove all impurity after answering the call of nature, because the Prophet warned against being careless in cleaning oneself after urinating: "Most of the punishment of the grave will be because of urine." Ibn 'Abbaas reported that the Messenger of Allah passed by two graves, and said: "They are being punished, but they are not being punished for any major sin. One of them used not to protect himself (i.e. keep himself clean from) his urine, and the other used to walk about spreading malicious gossip.

The religious/legal requirement for men to squat or sit while urinating may

**L**ast year, my daughter asked me to go with her to a Toastmasters International meeting. She'd read about the organization and thought it might help her improve her communications skills. Most local clubs are small, usually under 25 members. Ours - the Viera/Suntree Toastmasters Club - meets on the second and fourth Wednesday of a month. **A**t this writing, the Florida Legislature is still in session. The Florida House voted to approve the “Committee Substitute” for House Bill 655. In terms of the bill’s objective, the Committee Substitute does not substantially differ from the original bill. Yet, what is this bill about? To answer that, we need to review a little recent history.

Last year, a citizens’ group in Orange County decided to petition the county government to place a ballot initiative before the voters, which, if passed, would create a county ordinance requiring employers within the county who have 15 or more employees to provide up to 56 hours per year of paid sick leave (See my article in the November 2012 *SCAM*, “Sickening”). The petition drive had been successful and met all the legal requirements to be presented to the County Commission to include the sick leave measure on the November ballot.

Predictably, the local business groups, notably Disney and the local Chamber of Commerce, were less than enthusiastic about the prospect of Orange County businesses being required to provide paid sick leave to their employees. As a result, much litigation followed challenging the initiative and attempting to keep the measure off the ballot. After the smoke had finally cleared, the court finally ruled in favor of the petitioners but, because of the time element, effectively prevented the measure from going to the voters. In an effort to remedy this, the court has now ordered the measure to appear on the November 2014 ballot. Thus, the voters will have an opportunity to weigh in on whether Orange County will have a sick leave ordinance.

Back to the present, enter House Bill 655. This bill, if passed, would prohibit local government from requiring employers in its jurisdiction to provide employee benefits not required under state or federal law. The bill would not prohibit employers, including public employers, from providing these benefits to their own employees. At this time, the Senate version of this bill has not yet been approved. It is my guess that CS/HB 655 will soon become Florida law. If this happens, the Orange County ballot initiative will be rendered meaningless.

Yet, all is not lost. All House seats will be up for election next year. We have time to inform Florida voters how each candidate for reelection voted on this bill. Likewise, there is still time to begin a petition drive to place on the ballot an initiative making the proposed Orange County sick leave ordinance state law by amending the Florida Constitution to that effect. I believe that, no matter what political views Floridians hold, that most would support such a measure. Back in 2004, Florida voters overwhelmingly passed the Florida Minimum Wage, which cannot be repealed by the legislature. This happened despite a massive effort

by the Chamber of Commerce and its allies to characterize the measure as "Storm #5" (We had four major hurricanes that year and the measure was on the ballot as "Amendment 5").

Most Floridians work for a living, almost all for employers (*despite the lip service to "entrepreneurship"*). Moreover, if you patronize a business whose employee is working, although sick with a contagious disease, your own health may well be at risk as a result. If the business does not offer paid sick leave, his employee will most likely show up for work (as he cannot afford to lose the day's pay).

Finally, it seems that on many workers' issues, the majority of Florida's legislators' actions conflict with their constituents' views. The Minimum Wage amendment is one example of this. It is also evident from the very introduction of House Bill 655 that they fear a positive outcome on the Orange County ordinance proposal. However, Orange County voters could well vote "no" on the measure, but our legislators do not wish to leave this to chance. Is the voice of the people something that our elected representatives fear? If that is the case, why do we, as Florida voters, keep on electing them?

have begun with Mohammed, but the custom existed long before his time. There is a note in Richard Burton's translation of *A Thousand Nights and a Night* (1865), "*In the East women stand on minor occasions while the men squat on their hunkers in a way hardly possible to an untrained European.*" Herodotus, who wrote in the fifth century B. C. about Egypt says, "*The women stand up when they make water, but the men sit down.*"

This practice was strongly brought to my attention when I was in charge of designing the Saudi-Arabian Air Force Academy at Al-Kharj. There are no urinals in this all-male institution. We were directed by the Saudi liaison not to put any urinals in the academy and the toilets could not face Mecca.

Does the design of the *Poesia* presage the gradual dominance of Muslim values over that of Western ones?

**A**t the last AMC meeting, we had three discussion items that, in my view, are all parts of a larger issue: How do we connect members with other members who share the same interests? We heard an interesting presentation from our national SIG coordinator, Barbara Kryvko; our national membership officer gave a talk on how local groups can make new members feel welcome; and RVC-1 Andrew Heffernan and Heather Poirier spoke to us about the use of mobile technology to keep members in touch with one another.

Mensa has both local groups, based on geography, and special interest groups, based on common interests. Thus, a Mensan who lives in Miami and is interested in gardening, politics and travel, has two ways to meet other Mensans: Through local group activities, and through joining a Mensa special interest group devoted to gardening, politics or travel. Over the years, I have made many friends by both methods, and I encourage other Mensans to do the same. Look through our SIG list, available on the national Web site, to see which groups might interest you, and attend local group events to meet other local Mensans. Or, if you have an interest but we don't already have a SIG for it, start one. I will be more than happy to put you in touch with the necessary people to get your SIG formally recognized as a Mensa group.

At one time, there was a one-SIG per subject rule, which meant that if there was already a history SIG, nobody could start another one. We have come to realize that free market competition can be a good thing, so that rule has been repealed. If you're not happy with the direction in which a SIG to which you belong is going, feel free to start another one.

And this brings us to the subject of mobile technology. Once upon a time, members learned of Mensa events through print newsletters only; thanks to social media it is now possible to plan a spur of the moment event and have a dozen people show up for it. This is very exciting, because as it becomes easier and easier for people to stay in touch, spontaneity will allow for far more opportunities to meet up. This is a good thing.

I'm excited about the direction mobile technology is taking and I'm looking forward to seeing its use expand. In the meantime, opportunities to be social have exploded; please take advantage of them. Other people look forward to meeting you.
